

# TOPIC: First aid awareness in the workplace

When accidents occur, it is critical that procedures be followed to assist the injured individual as quickly as possible. Therefore, it is crucial to familiarise yourself with the SHE-DOC-01 Emergency Procedures which outline how emergencies are managed.

Keeping in line with SHE-DOC-05 Incident Reporting Procedure, all employees,

visitors and contractors are responsible for reporting any incidents and injuries before the end of shift/day to their Supervisor, Manager or Site Representative in order for them to be addressed accordingly.

#### There are appointed first aiders within the workplace and their role includes:

- Being readily available during working hours/shift to administer first aid when required.
- Reporting any injuries to the Emergency Controllers.
- Ensuring that the first aid box/es remain stocked to meet all foreseeable incidents which may occur.
- Being familiar with the material safety data sheet (MSDS) for the particular substance/s in the workplace with particular reference to the first aid measures that need to be applied in case of an emergency.

### Therefore, to allow prompt response in an emergency, be sure to know the following:

- Where the first-aid kit is kept.
- Who your first aiders are.
- Where the phone (or other means of contact e.g. radio) is located in order to call for help.
- First aid equipment and supplies should be stored where they can be reached quickly and easily in the event of an accident.
- These supplies should be inspected frequently by first aiders, making sure they are kept
  in sanitary and usable condition and re-stocked after use. Inspection to be done according
  to SHE-FORM-02 First Aid Box Checklist.
